

Casey's Say Cheese Free Pizza For One Year Giveaway ("Sweepstakes")

OFFICIAL RULES ("Rules")

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ENTRIES RECEIVED DURING THE SWEEPSTAKES PERIOD. VOID WHERE PROHIBITED BY LAW. ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

ELIGIBILITY: The Sweepstakes is open only to persons who, at the time of entry, are eighteen (18) years of age or older at the time of entry and are legal residents of the State of Oklahoma. Employees, officers, and directors including immediate family members - i.e., spouse, parent child, sibling and their respective spouses, regardless of where they reside – and members of the same household, whether or not related) of the Oklahoma City Baseball Club (the "Club") and the Casey's ("Sponsor"), and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a Grand Prize ("Grand Prize"). SWEEPSTAKES PERIOD: The Sweepstakes period will begin at 12:00 M Central Time ("CT") on April 2, 2024, and end at 11:59 PM CT on September 15, 2024 ("Sweepstakes Period").

HOW TO ENTER: To enter the Sweepstakes, simply register by accessing the online form via the QR code or at <https://www.milb.com/oklahoma-city> and click "Enter Now." Entrants must fully complete and submit all non-optional data requested upon completing the form to be eligible. Incomplete and/or inaccurate entries are void. All data inputted via the online form becomes the property of Sponsor. No other method of entry will be accepted. One entry per person/phone number/email address. Non-winning eligible entries from the Sweepstakes will not carry over to any subsequent sweepstakes or promotion.

RANDOM DRAWING: The Grand Prize winner of the Sweepstakes will be selected by random drawing on or about September 16, 2024, from among all eligible entries received during the Sweepstakes Period (each a "Winner" and collectively, the "Winners"). The decision of Sponsor are final and binding on all matters relating to the Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Sweepstakes Period.

GRAND PRIZE: There will be one (1) Grand Prize awarded. The Grand Prize will include free Casey's pizza for one year.

PRIZE NOTIFICATION RESPONSE TIME: Forty-Eight (48) hours from the time of issuance of the Prize Notifications (defined below) (the "Required Response Time").

PRIZE CONDITIONS: All Grand Prize details, including, without limitation, the exact game date and seat locations at the game, if any, shall be determined in the sole and absolute discretion of Sponsor and/or Club, as applicable. Each Winner is fully responsible for any and all applicable federal, state, territory, provincial and local taxes (including income and withholding taxes).
